PARTICIPANT AGREEMENT & RELEASE OF LIABILITY -- READ BEFORE SIGNING

In consideration of being allowed to participate in any way in Hardkour Ninja Unlimited's program, its related events and activities, I, _____, the undersigned, acknowledge, appreciate, and agree that:

1. I acknowledge that my participation in Parkour and Freerunning training and instruction activities and all other related activities inside and outside this facility entails known and unanticipated risks that could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity.
2. The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular skills, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,
3. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and,
4. I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the Company immediately; and,
5. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS Hardkour Ninja Unlimited, their officers, officials, agents and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and lessors of premises used for the activity ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.
6. Management: Management of Hardkour Ninja Unlimited may suspend or cancel the rights, privileges, or membership of any member whose actions are detrimental to the enjoyment of the facilities by other members or any conduct which in the opinion of the management is prejudicial to welfare, good order, and character of Hardkour Ninja Unlimited. Any inappropriate behavior, including profanity or yelling, incidental to the enjoyment of the gym by other members may result in membership termination without a refund and any registration fees shall be forfeited. Management has the right to cancel any membership for non-payment of their membership account balance.
7. Permission for Emergency Medical Treatment: I confirm that I am/my child is in good health and I hereby authorize simple first aid and consent to any x-ray, exam, and medical or surgical diagnosis which is deemed necessary in case of an emergency.
8. I hereby agree that I am responsible for all cost incurred for the collection of any delinquent payments, including but not limited to attorney fees.
9. I give my permission for photos and videos of myself/my child taken during classes, open gyms, and/or competitions to be used on Hardkour Ninja Unlimited's website, social media, and other marketing materials.
